- Lights powered by batteries shall be marked with a means of determining their age or the date by which they are to be replaced
- Each light is to be marked with the information required by the LSA Code Paragraph 1.2.2.9 and 1.2.3
- For compliance with SOLAS Regulation III/35 and III/36, fully detailed operations and maintenance manuals shall be supplied with each light
- The lifejacket type where the subject design of light is fitted should be tested in accordance with IMO Resolution MSC.81(70), I/10.3.3 to confirm the adequacy of their means of attachment
- Lights which have reached their date of replacement shall be disposed of safely with due regard to their lithium batteries
- The arrangement and installation of the lights on the lifejacket on board are not part of this design appraisal or certificate and are to be to the satisfaction of the Surveyors attending on board
- If the specified standards are amended during the validity of this certificate, this product type is to be re-approved prior to it being supplied to vessels to which the amended standards apply
- Production items are to be manufactured in accordance with either an approved Production Quality Assurance system (Module D) or Product Quality Assurance (Module E) or Product Verification (Module F) of the Marine Equipment Directive
- Production tests are to be conducted to ensure compliance with SOLAS Chapter III Regulation 5 and recorded by the manufacturer in accordance with either the approved Production Quality Assurance system (Module D), or Product Quality Assurance (Module E), or witnessed by the Notified Body (LRV) as required by the Product Verification (Module F) of the Marine Equipment Directive. This does not preclude any further testing to additional requirements of the Marine Administration of the country where the ship is registered (i.e. the flag state) or those acting on behalf of that Administration
