- Lights powered by batteries shall be marked with a means of determining their age or the date by which they are to be replaced
- Each light is to be marked with the information required by the LSA Code Paragraph 1.2.2.9 and 1.2.3
- The lifejacket type where the subject design of light is fitted should be tested in accordance with IMO Resolution MSC.81(70), I/10.3.3 to confirm the adequacy of their means of attachment
- For compliance with SOLAS Regulation III/35 and III/36, fully detailed operations and maintenance manuals shall be supplied with each light
- Lights which have reached their date of replacement shall be disposed of safely with due regard to their lithium batteries
- The arrangement and installation of the lights on the lifejacket on board are not part of this design appraisal or certificate and are to be to the satisfaction of the Surveyors attending on board
- If the specified standards are amended during the validity of this certificate, this product type is to be re-approved prior to it being supplied to vessels to which the amended standards apply
- Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure compliance with SOLAS Regulation III/5
- Production tests are to be conducted in accordance with the applicable requirements of IMO Resolution MSC.81 (70), Part 2 and each item, batch, or lot be delivered with an LR Certificate of SOLAS Production Testing issued by the attending LR Surveyors following their witness of the tests. This does not preclude any further testing to additional requirements of the Marine Administration of the country where the ship is registered (i.e. the flag state) or those acting on behalf of that Administration
- Should a change of Place of Production from that stated below be required i.e. where the stages of manufacture/assembly/testing of this product take place, the new Place of Production is to be advised to us prior to the change taking place. This Certificate will require to be updated for Approval to be maintained
