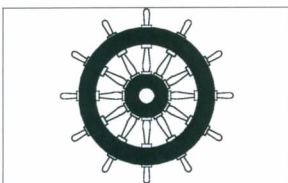

**CONDITIONS OF CERTIFICATION**

1. This lifejacket light is for attachment by recessing into buoyancy foam only; lifejackets are to be of types specifically designed for this.
2. Replacement of the batteries is not allowed and their removal should not be possible without destroying the container. The date of expiry of the light shall not exceed 50% of the service life of the battery as established by the battery manufacturer .The light unit must be replaced on or before the expiry date marked on its label.
3. Detailed fitting, maintenance and in service test instructions are to be provided to each purchaser of the subject lights.
4. Each light is to be marked with the information required by the LSA Code Regulation 1.2.2.9 and ISO 24408 Paragraph 4.3.
5. The lifejacket type where the subject design of light is fitted should be tested in accordance with IMO Resolution MSC.81(70), I/10.3.3 to confirm the adequacy of their means of attachment.
6. If the specified standards are amended during the validity of this certificate, this product type is to be re-approved prior to it being supplied to vessels to which the amended standards apply.

7. The arrangements and installation of the lights on board are not part of this design appraisal or certificate and are to be to the satisfaction of the Surveyors attending on board.
8. Production items are to be manufactured in accordance with either an approved Production Quality Assurance system (Module D) or Product Quality Assurance (Module E) or Product Verification (Module F) of the Marine Equipment Directive.
9. Production tests are to be conducted in accordance with the applicable requirements of IMO Resolution MSC.81(70), Part 2, Paragraph 1.2 and ISO 24408:2005 Annexe A-Production testing and inspection procedures, and they must be recorded by the manufacturer in accordance with either the approved Production Quality Assurance system (Module D) or Product Quality Assurance (Module E) or witnessed by the Notified Body (LRV) as required by the Product Verification (Module F) of the Marine Equipment Directive. This does not preclude any further testing to additional requirements of the Marine Administration of the country where the ship is registered (i.e. the flag state) or those acting on behalf of that Administration.
10. Each item, batch or lot of the equipment is to have the "Mark of Conformity" affixed and be issued with a "Declaration of Conformity"
11. Should a change of Place of Production from that stated below be required i.e. where the stages of manufacture/assembly/testing of this product take place, the new Place of Production is to be advised to us prior to the change taking place. This Certificate will require to be updated for Approval to be maintained.
