

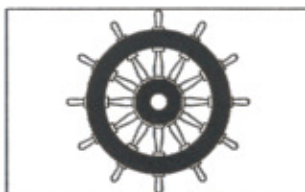

Production tests are to be conducted to ensure compliance with SOLAS Chapter III Regulation 5, MSC.81(70) Part 2 Paragraph 1.2 and ISO 24408 (2005) Annexe A -Production testing and inspection procedures; they must be recorded by the manufacturer in accordance with either the approved Production Quality Assurance system (Module D), or Product Quality Assurance (Module E), or witnessed by the Notified Body (LRV) as required by the Product Verification (Module F) of the Marine Equipment Directive. This does not preclude any further testing to additional requirements of the Marine Administration of the country where the ship is registered (i.e. the flag state) or those acting on behalf of that Administration.
